AGREEMENT

THIS AGREEMENT made on this 25th Day of July, 2025 between M/s Ferrosang Enviro Solutions Pvt. Ltd., having its bio-waste management plant located at Khasra No. 925 & 1612, Village-Rasulpur, Pargana-Salon, Tahsil-Unchahar, District-Raebareli (U.P.) (Hereinafter called as "FIRST PARTY" which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors nominees and assigns of the First Party).

And

M/s Sitaram Plastic, a company registered as a proprietorship firm, having its registered office and plant at NJ-232, Sector-3, Bawana Industrial Area, Delhi, duly authorized by the Delhi Pollution Control Committee to recycle all kind of plastic waste including PVC under Plastic Waste Management Rule 2016 (Hereinafter called as "SECOND PARTY" which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successor nominees and assigns of the Second Party).

First Party is engaged in the processing of Bio Medical Waste Management. During the said process/ activities different types of plastic wastes are generated. (The list of different types of plastic waste and their tentative quantities, which are generated at the First Party's plant is enclosed herewith in **Annexure A**).

The First Party desires that the plastic waste being generated at its production unit (as mentioned above), shall recycled disposed of, by utilizing the services of Second party, as per the guidelines of Delhi Pollution Control Committee.

AND WHEREAS the Second Party has represented and assured to First Party but it's facility in Delhi is duly authorized by Delhi Pollution Control Committee and further is capable of handling and treating the Plastic waste being generated at First party's premises.

Now, therefore these present witnessed and it is hereby declared and agreed by and between the Parties as follows:

- 1) The scope of services to be provided by Second Party is limited to recycling or disposing of plastic waste of First Party as per the guidelines prescribed by the Pollution Control Board.
- 2) First Party shall ensure that Plastic Waste must be segregated and stored as instructed by the Second Party to prevent spoliation of plastic waste. Also, the Second Party reserves the right to reject the plastic waste if it is spoiled, due to other waste, fire, water or any other reason whatsoever.
- 3) Second Party shall at all times comply with all the provisions of Plastic Waste Management Rules, 2016 as amended from time to time.
- 4) First Party will provide the required labour at its own cost for the lifting and loading of Plastic Waste from the First Party's premises. The cost of transportation shall also be borne by the First party.
- 5) First party has mandatory obligations to provide the entire process details which lead to generation of Plastic Waste and its tentative quantity per month to Second Party for the purpose of determining the waste characteristics and to decide parameter for comprehensive analysis and process for management. However, it is specifically agreed between the parties that the process details provided by the First Party shall be kept confidential and Second Party shall not disclose it to any third party (except Government Authorities) without First Party's prior consent till the validation of this Agreement.
- 6) The First Party shall not take services of any unauthorized vendor for the purpose of plastic waste management while this agreement is in force. If found guilty then the Second Party will not be responsible for any action being taken by concerned authority.
- 7) Second Party shall make payments within 7 working days from the date of lifting of waste from Second Party's premises. In of delay Second Party can charge suitable interest on the amount.

- 8) This Agreement is valid till 25th July-2027, it shall expire with immediate effect if Consent to Operate under Air & Water Act obtained by any of the parties expires or gets suspended by the concerned pollution department during this period.
- 9) If all the terms and conditions as per the clause of this agreement are adhered to by the First Party, it will be Second Party's responsibility to recycle/dispose of the Plastic Waste being provided by First Party as per the method prescribed by the Pollution Control Board.
- 10) Notwithstanding anything contained herein, neither party hereto shall be liable for damages or have this Agreement terminated for any delay or default in the performance of such Party hereunder if such delay or default in performance derives from conditions beyond the reasonable control of such party, including but not limited to, acts of God, fires, floods, riots, road blockings, work stoppages, governmental actions or any cause unavoidable or beyond the control of either party.


IT IS FURTHER HEREBY AGREED BY AND BETWEEN THE PARTIES AS UNDER:

- 11) This agreement shall be deemed to represent the entire agreement between the parties hereto regarding the subject matter hereof and shall supersede, cancel and all prior agreements or arrangements, if any, in this behalf signed/entered into by and between the parties hereto.
- 12) This agreement is on principal to principal basis and nothing contained herein shall be deemed to constitute a partnership, joint venture by and between the parties hereto.
- 13) This agreement may be modified or amended only by writing, duly executed by or on behalf of the parties hereto.
- 14) Any terms and conditions of this agreement may be waived at any time by the party that is entitled to the benefit thereof. Such waiver must be in writing and must be executed by an authorized officer of such party. A waiver on one occasion will not be deemed to be a waiver of similar occasion or any other similar breach or non-fulfillment on a future occasion.
- 15) If any provision of this agreement is held to be illegal, invalid or unenforceable under any present or future law, such provision shall be deemed terminated and the remaining party and provisions of this agreement shall remain in full force and effect.
- 16) Either party shall have the right to terminate this agreement upon giving 30 days written notices to the other Party with a reasonable cause.
- 17) It is clearly understood by and between the parties that the activity of recycling and disposing of Plastic Waste is an independent contract and does not come within the purview of the First Party's manufacturing and selling activities. It is also clearly understood and confirmed by and between the parties that this contract is for performance of work and not for supply of labour.

- 18) Nothing contained in these terms and conditions shall be construed as creating any relationship either direct or indirect of employer and employee between the First Party and the persons engaged by Second Party.
- 19) Any dispute arising on any clause or clauses of this agreement and the contents of the Annexure hereto between First Party and Second Party shall be referred to an Arbitrator of repute by Second Party. The Arbitration shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996 with amendments thereof. The arbitral award, including interim award, if any, shall be final and binding upon both the parties.
- 20) Subject to the provisions of the foregoing clause, First Party and Second Party mutually agree that the courts of Delhi alone, to the exclusion of any other, shall have the jurisdiction.
