Taxes: All applicable taxes are additional and shall be paid by the client as per prevailing laws.


Exclusive Arrangement: This Agreement is solely between the stated parties and does not involve or benefit any third party.



Confidentiality Commitment: Both parties are obligated to keep shared information confidential and shall not disclose it to any third party unless mandated by law.
